## MEMORANDUM OF UNDERSTANDING (MOU)

## **BETWEEN**

THE GENEVA FOUNDATION FOR MEDICAL EDUCATION AND RESEARCH located at Chemin Edouard-Tavan 5, CH - 1206 Geneva

## **AND**

THE NATIONAL CENTER FOR SEXUAL AND REPRODUCTIVE HEALTH located at Raniwala House 39-Sulaman Street New Islamia Park Lahore, Pakistan



Article I: By signing this MOU we start collaboration between the two parties for the exchange of knowledge.

Article II: The exchange of knowledge and experience will be in the field of Medicine and Public Health. Both the parties agree to have exchange programs of personal for teaching, training, research and project development and implementation. It is also agreed to collectively:

- i) Organize courses, conferences, seminars, workshops and diplomas.
- ii) To collaborate in scientific work.
- iii) Collaborate in research projects and exchange ideas and information related to scientific research.
- iv) To develop and implement existing and new training programs.

Article III: The parties agree with each other to organize courses run by them in each others country or in other countries collectively for individuals who can not travel to the other country.

Article IV: The two parties will exchange scientific publications, results, teaching materials, clinical and basic sciences experiences.

Article V: To collaborate and publish scientific research collectively. To also favour bilateral participation in meetings, training programs and workshops in each others country.

Article VI A joint coordination committee will be constituted by both the parties which will evaluate contribution made by both parties and submit to both the parties regarding annual performance.

Article VII: Both the parties will facilitate researchers and office bearers from each party when they visit each others country for research, teaching, meetings or associated activities.

Article VIII: Both the parties agree to facilitate each other in fund raising for conducting the activities mentioned above through fundraiser programs either through internet or otherwise or through involvement of a third party in each others country.

Article IX: Both the parties subject to availability of funds agree to facilitate each others members to conduct research, clinical training in each others country. In case funds are not available then only facilitation will be provided.

Article X: Both the parties agree to publish a joint newsletter on quarterly basis highlighting the activities of both the organizations related to the collaboration subject to funding.

Article XI: In case any modification is made to the present contract it has to be given to the other party in writing and only after both parties agree will it become a part of this document.

Article XII: This is a perpetual agreement which does not require renewal. However	if one
part wants to get out of it, it has to give a six months notice in writing in advance.	

We hereby lay our hands together to sign this document in the largest interest of scientific knowledge and humanity.
